Resolution No. FPC 85/2009/1 dated 4/2/2010 as published in the Extra Ordinary issue No. 25 of the Assam Gazette dated 4/2/2010 regarding the regulation/revision of pension/family pension in respect of Pre 1/1/2006 pensioner/family pensioner. I am directed to say that the Government in the P & P 3. Department have already issued necessary OFFICE MEMORANDUM and communicated to all concerned vide Govt. O.M No.- PPG(P) 88/2010/26 dated 1/6/2010.


It has come to the notice of the Govt. that, ~~dispute has arisen~~ in the minds of some implementing authority as to the applicability of Section 3(b)(I) of the said O.M in connection with the fixation of revised pension of Pre 1/1/2006 pensioner/family pensioner causing confusion in disposing of pension cases of concerned pensioners, whose cases are governed as per the Assam Service (Pension) Rules 1969.

The Finance ERU Department was consulted and the Department vide their U/O No.FPC 147/2010 dated 30/9/2010 and No.FPC89/2012 dated 26/7/2012 has further clarified the matter that the provision contained in para 3(b) (I) of office Memorandum No.PPG(P)88/2010/26 dated 1/6/2010 appears to be clear and is in order.

In view of above, you are requested to take in to account the Ready Reckoner and the provision of Section 3(b)(I) of the O.M. No.PPG(P)88/2010/26 dated 1/6/2010 while fixing of pension/family pension of Pre 1/1/2006 pensioner subject to the maximum limit of Rs.27,500/- (twenty seven thousand & five hundred) per month.

It is further clarified that this order shall be applicable to pensioner those who have drawing pension on 01/01/2006 in the Pre Revised Scale.


